(a) It was informed to the august house that a new faculty in the name of Faculty of Behavioral and Social Sciences(FBSS) from the academic session 2017-18 has been created and approved by BOM vide Resolution No: 'C' (Under any other items) of its meeting held on 13.04.2017 . It will comprise four courses-Psychology, Economics, Social Work & Life Long Learning presently three courses B.A (Hons.) Economics, B.A-Applied Psychology and MA-Applied Psychology are in operation and they along with faculty have been transferred to the new faculty-FBSS . Prof. N.K. Chadha has been appointed as Dean of the faculty.

(b) It was further informed that the Department of Commerce, Faculty of Commerce & Business Studies, MRIU has received a consultancy project on implementation of GST from a senior advocate from Gurgaon, Adv. R K Soota with the following objectives for a period of three months:-

- (i) To help them in transition of their 300-400 clients from existing tax regime to the GST regime
- (ii) Facilitation in identifying technologies and platforms for GST implementation
- (iii) Organization of their GST team
- (iv) Training of their staff members and clients through MDPs and Seminars

Through the project the University is contributing in the biggest tax reform of the country, GST implementing from 1st July, 2017. The project focuses on the practical application and effective management of GST through the transition phase.

Prof. Monika Goel, HOD of Commerce is the Principal Investigator.
