Dr. Krishna Kant ED & Dean FET MRIU mentioned that there are presently 43 students placed in the companies which have asked for placement in January 2018. In order to facilitate these students in their career, a FASTTRACK Semester has been planned by FET. Following are the salient points of the proposal:-

- (a) FAST TRACK Semester will work on the model of Summer Semester for lecture and lab delivery equivalent to 12 weeks.
- (b) The  $8^{\rm th}$  Semester has theory subjects and Lab and a Project Phase-II/ Industrial Project.
- (c) It is proposed that students would complete their project in the industry where they are placed.
- (d ) Total no. of contact hours required for 3 theories subject (credit 3+3+4=10) and two lab course (credit 2+2=4) per week would be 14 hours in case of CSE.

Thus total contact hours required would be 168 hours taking summer Semester as the model.

The load for sessional exam-I & II would be 4.5+4.5=9 hours. The End Semester Examination for  $7^{th}$  Semester is likely to be finished by  $15^{th}$  Dec 2017 and it is proposed to start the Semester from  $18^{th}$  December 2017 with the following schedule:-

Week 1	18 Dec - 23 Dec	$8 \times 5 = 40 \text{Hrs}$
Week 2	26 Dec - 30 Dec	8 x 5 = 40Hrs
Week3	02 Jan – 06 Jan	8 x 6 = 48Hrs
Week4	08 jan-12 Jan	8 x 5 = 40Hrs
Week5	15 Jan- 19 Jan	$8 \times 5 = 40 \text{Hrs}$

The proposed Summer Semester is likely to be over by 19<sup>th</sup> January 2018 as per above schedule. The final exam for these students will be in May-June 2018 along with the other students. The attendance criteria for final exam are proposed to be 75% or it may be decided by Vice Chancellor alongwith other students of normal Semester.

The industry project would have two mentors from FET MRIU and one from industry. It is proposed to evaluate the project jointly by industry and concerned department. There would be regular meetings between students and FET mentor to evaluate the progress of the work.



All departments of FET have mapped their  $8^{\text{th}}$  Semester curriculum with FAST TRACK Semester based on above proposal.

AFTER DISCUSSION, IT WAS RESOLVED THAT THE ABOVE PROPOSAL OF THE ED & DEAN FET BE APPROVED WITH THE STIPULATED THAT END SEMESTER EXAMINATION OF SUCH STUDENTS SHALL BE HELD ALONGWITH OTHER REGULAR STUDENTS OF NORMAL SEMESTER.
