For the year 2020-21, the council for doctoral program initiated the admission process by inviting the vacancies from the various departments which offer the PhD in various subjects. The vacancies thus received were discussed with the competent authority for declaration. Post approval from the office of Chancellor the advertisement for inviting the application was done through the website. A total of 235 vacancies were declared under 28 departments in May 2020

The CDP received 223 admission applications out of which 48 applicants were exempted under JRF/UGC NET and MPhil category. 175 Students were called for written examination out of which 148 students appeared for the entrance test. Team CDP conducted written test of 148 students out of which the 8 students could not clear the written test.

With the process in place the admission tests were prepared by the academic heads of the department. The test was conducted online with the help of a reputed third-party service provider. The result of the entrance test was declared on the 11th August through website and departments were briefed to move ahead with the interview process. The Final merit list was declared through website on 21st August 2020 consisting of 144 scholars and 11 Wait listed candidates. **(Annexure 34.46.01)** The summary table is as follows:-
