You deserve all-round appreciation for conducting marathon meeting of AC. As my neatly and emotionally involved in the academics of course the life of students is dependent on it and how much they are swallowing during their stay here, two humble submissions from my side are put here as under for your kind perusal

For the last more than one year we are under the shadow of covid and by and large we are following on line mode. Till now it was through class room. Being the maiden experience the doubt is whether online is as much effective as it was off line. We cannot rate off line because it was de-facto. Without any option other than on line we are not receiving feedback from the students. Generally what we see from the teaching and answer sheets, students are on average dependent on the notes given out by the faculty. It appears that they are not doing intensive reading which ought to have been done when they are cut off from class room delivery because teachers had been citing additional material there. Similarly evaluation of answer sheet on the small screen mobile or computer does not give full impression of what has been written and whether marking is meticulous and judicious. What we can do in these challenging times is that we can emphatically tell the students that they should have printed reading material with them before the session starts. We should tell them they should thoroughly read the contents from the printing material. Whether they would do it or not we can supplant extra viva over the span of the session and do the extrapolation of the marks recorded in answersheet given the name moderation in order to fall in line with the statute where by marks are divided.

The second submission: In Ph.D situation in 90 percent cases we are going with one internal supervisor but in 10 percent cases it could be joint supervision also. There are three situation where some break is possible.

One the scholar and guide are not in tune with each other, but allotment was only in one minute decision.

Second the scholar is shy of continuing with recommended guide but it keeps lingering for long time.

Thirdly scholars have some other family reasons to remain steadfast with the work.



In single supervision there are chances of internal supervisor leaving the job altogether and then not interested in adopting the scholar further on.

Somehow these glitches can be resolved to large extent in case and where option is exercised to chose co-supervisor in the initial stage but as a freedom to do it. It appears it is not a very healthy situation when supervisors are changed due to any of the reason cited above. No doubt it is exercised but there cannot be happy going in the long time for the reason specialisation and thought process of one guide is different from the guide changed due to any reason. Co-supervisors initially chosen can somehow avert the breaks caused.
