Considered the Scholarship Policy for Online Programmes as follows:-

On Merit Basis

For UG Programmes:

- > 85 % and above marks / CGPA in Qualifying exam will be awarded 75 % tuition fee waiver.
- > 80% to 84.99% marks / CGPA in Qualifying exam will be awarded 50% tuition fee waiver.
- > 75% to 79.99% marks / CGPA in Qualifying exam will be awarded 25% tuition fee waiver.
- > 70% to 74.99% marks / CGPA in Qualifying exam will be awarded 10% tuition fee waiver.

For PG Programmes:

- > 80 % and above marks / CGPA in Qualifying exam will be awarded 75 % tuition fee waiver.
- > 75% to 79.99% marks / CGPA in Qualifying exam will be awarded 50% tuition fee waiver.
- > 70% to 74.99% marks / CGPA in Qualifying exam will be awarded 25% tuition fee waiver.
- > 65% to 69.99% marks / CGPA in Qualifying exam will be awarded 10% tuition fee waiver.

Condition for Continuation of Scholarship Policy

Maintain a minimum CGPA of 6.5 Annually (1st and 2nd Semester). However, if any student considered for fee concession in the first year fails in any of the subjects, he/she may be considered for continuation of fee concession provided that he/she shall have to clear the subjects in the subsequent academic year failing which he/she will not be considered for the continuation for the fee concession.
