Session on Research and Innovation Ethics

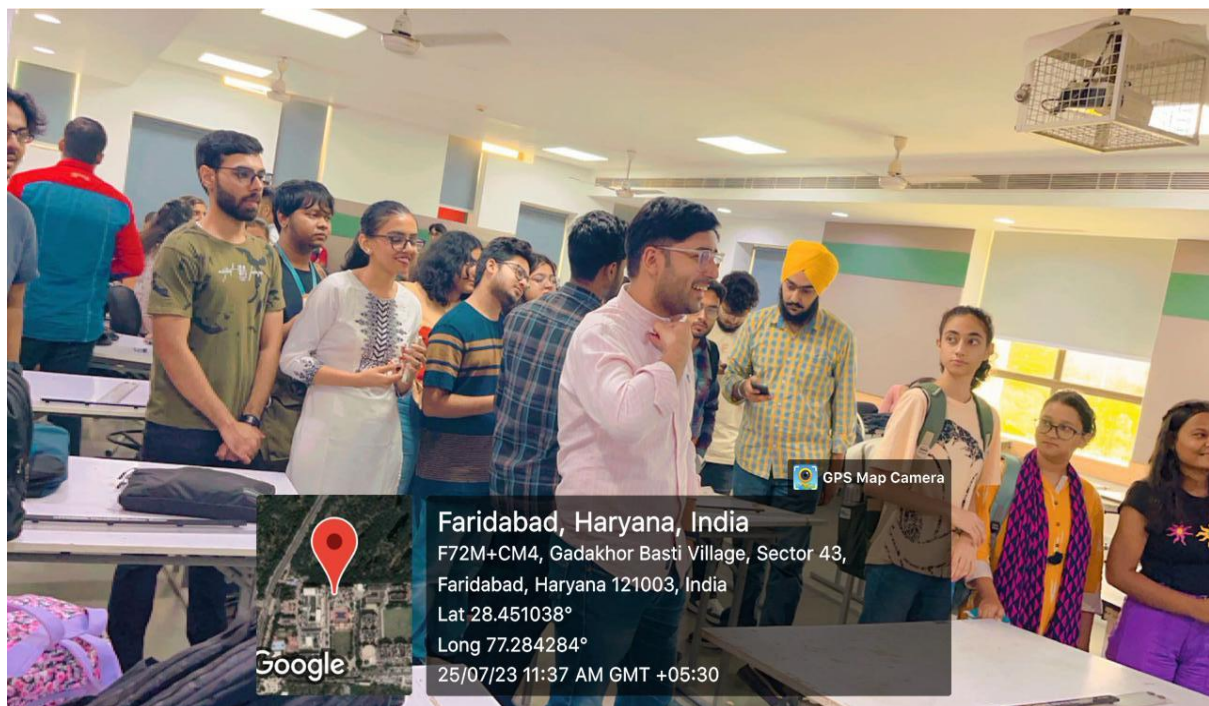

He emphasized the need for honesty, transparency, and objectivity in research and innovation to ensure the credibility and impact of their work.

“Ethical Considerations in Research and Professional Practices”

The Sustainable Squad, The Department of Civil Engineering, Faculty of Engineering and Technology, Manav Rachna International Institute of Research and Studies organized an Expert Talk on “Ethical Considerations in Research and Professional Practices” on the occasion of Global Ethics Day 2022 on October 19, 2022. Out of 65 registered candidates, 57 participants of various organizations around India attended the event. The Eminent speaker of the event was Ms. Amita Bhati, presently working as an Assistant Professor in the Centre for Languages and Communication, Shree Guru Gobind Singh Tricentenary University (SGT University), Gurugram, Haryana. In her talk, she was by discussing the concept and functioning of “Institutional Ethics Review Board” of Jawaharlal Nehru University, New Delhi. Ms. Bhati gave emphasis on various Ethical Considerations such as Respect for Privacy, Beneficence, Respect for Anonymity and Confidentiality, and Informed Consent. Ms. Bhati also explained the difference between the concept of Fabrication, Falsification, and plagiarism. Ms. Bhati further gave a detailed explanation on different types of plagiarism: Self Plagiarism, Accidental Plagiarism, Direct Plagiarism, and Mosaic Plagiarism, followed by the software applications which are currently using by the researchers to determine the plagiarism percentage.

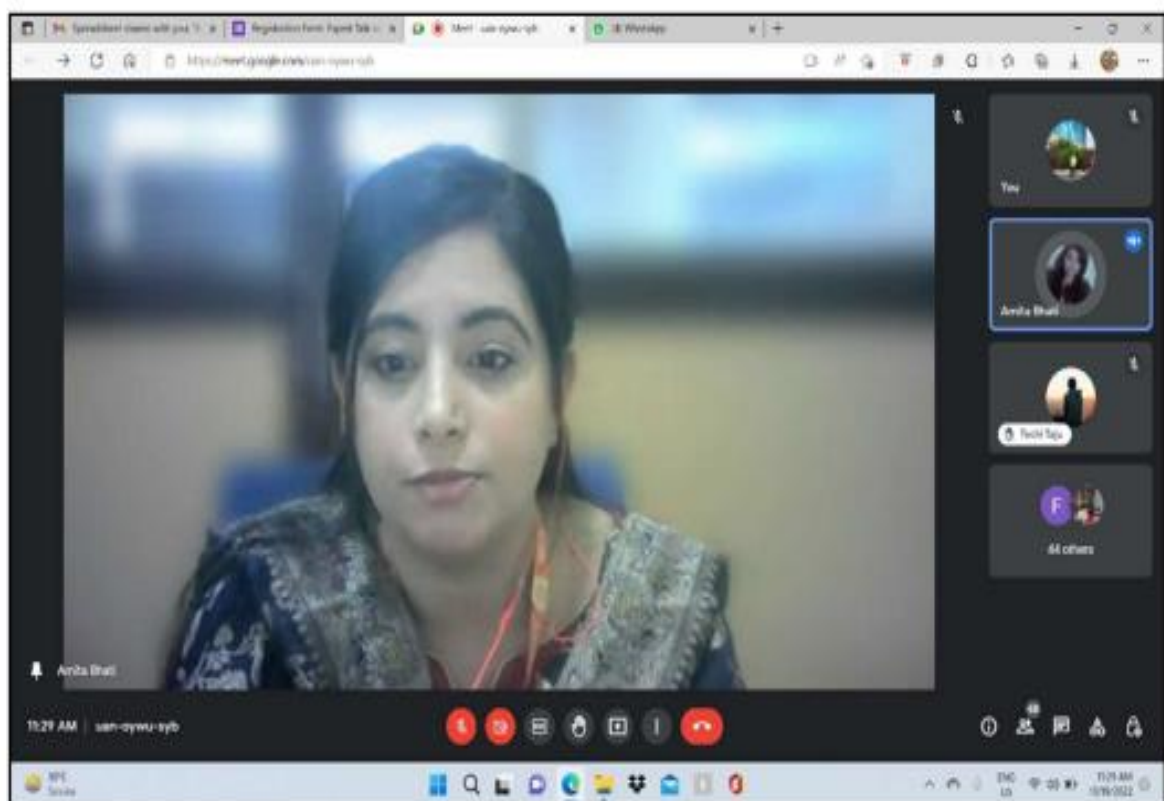
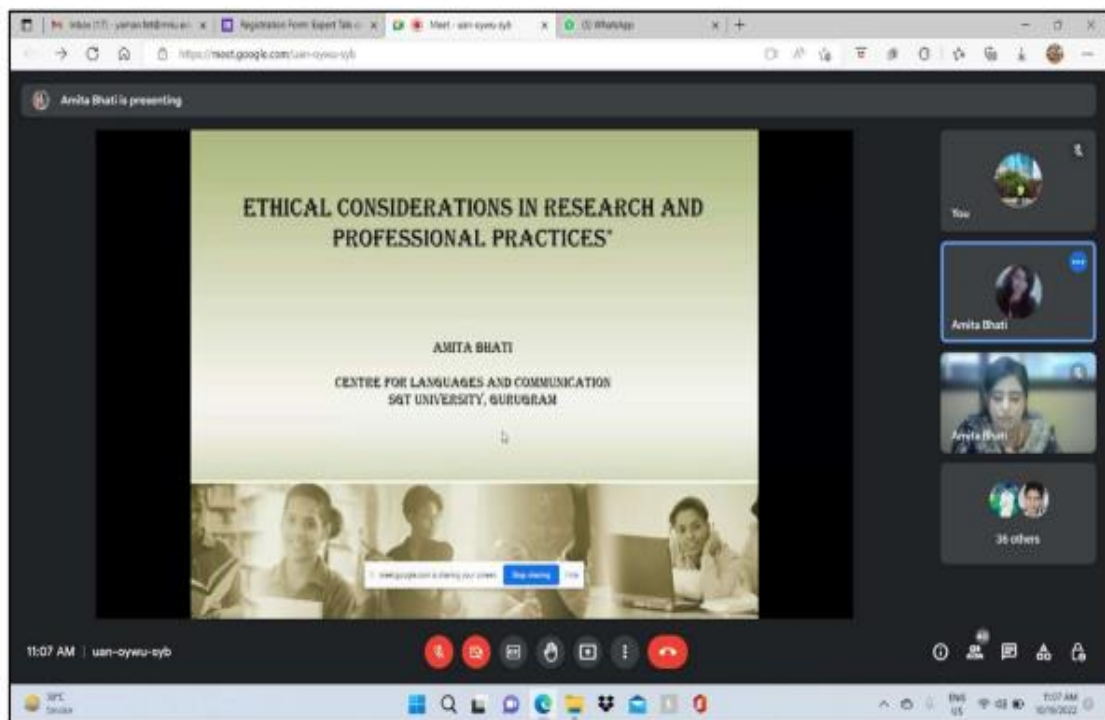

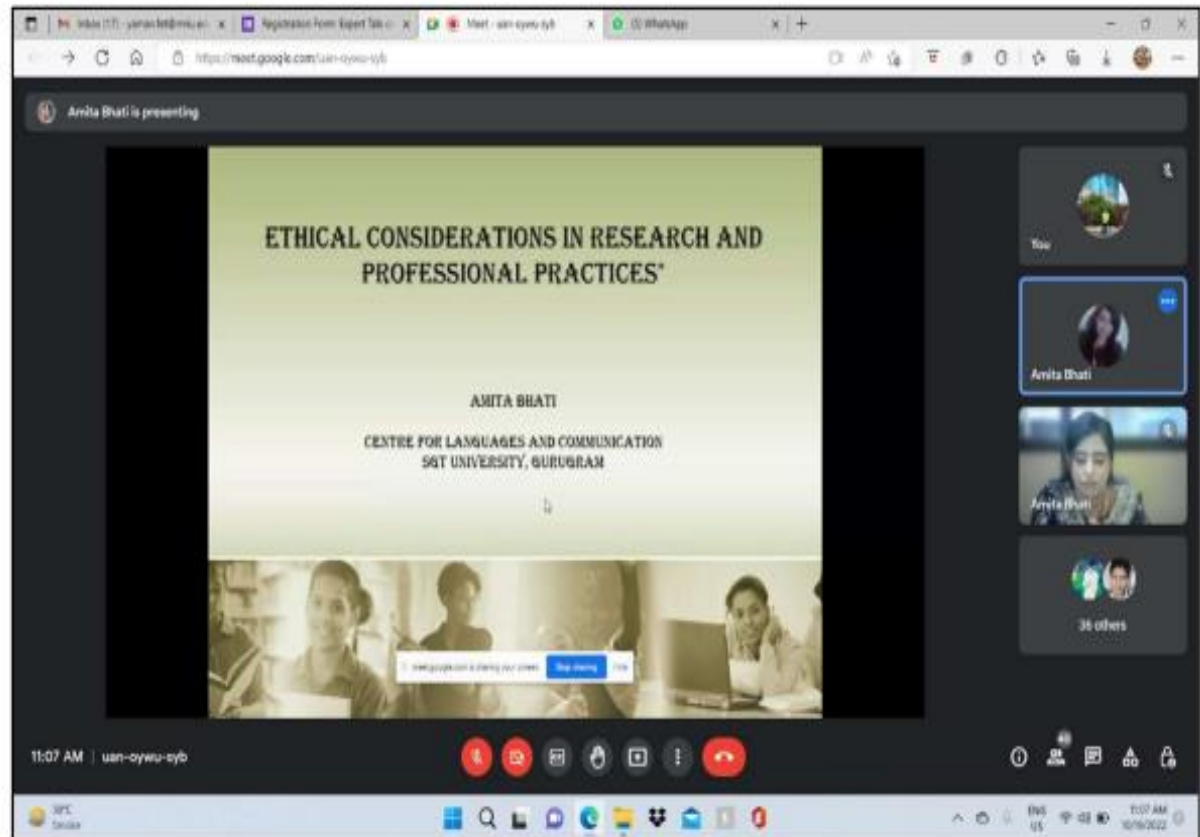

Prof.(Dr) Amit Seth and Dr.Vinit Sikka, the program's speakers, explained the importance of theories of business ethics practices in the corporates. They mentioned that all the business ethics practices are divided into two broad groups called teleological theories and deontological theories. Further, they elaborated the theories.

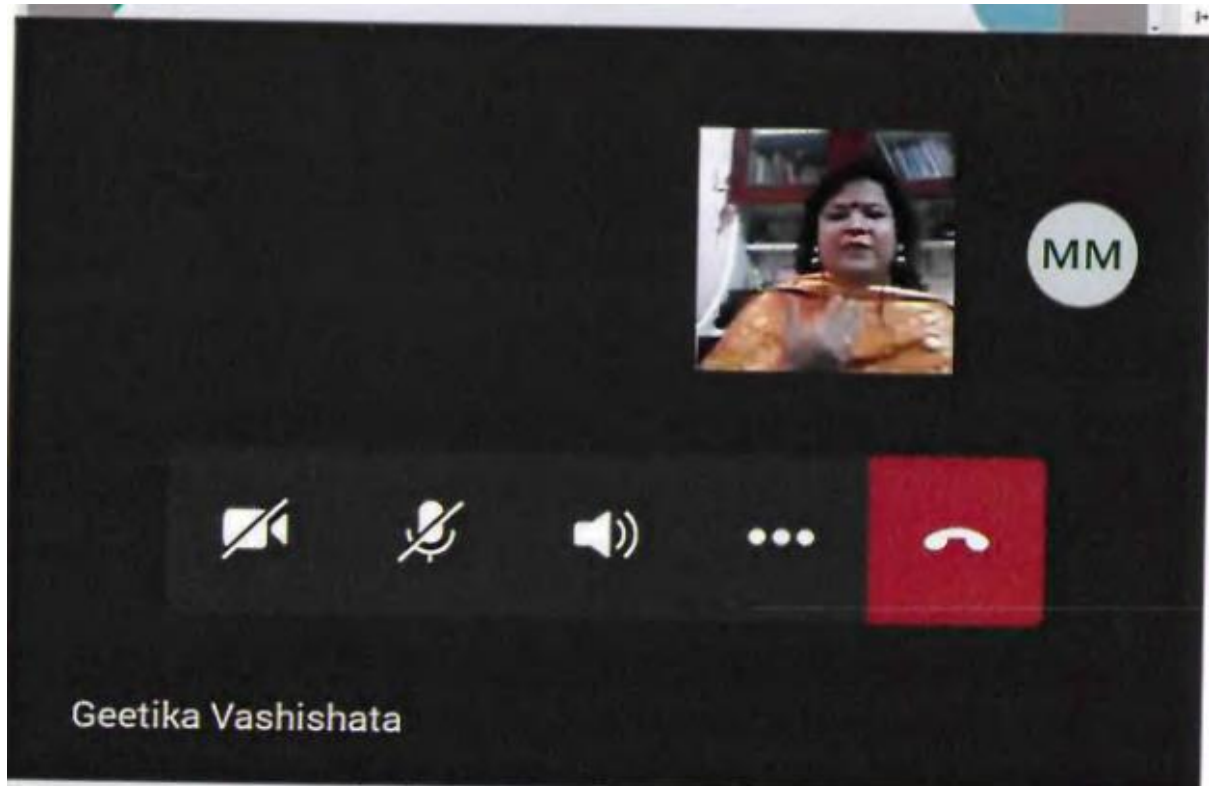
Workshop on Social Media Ethics at workplace

The event was organised on MS Teams. Ms Geetika Vashishata, Assistant Professor at the Department made a presentation on the topic that was taken forward for discussions by other faculty members.

Positive Ethics in Everyday Life

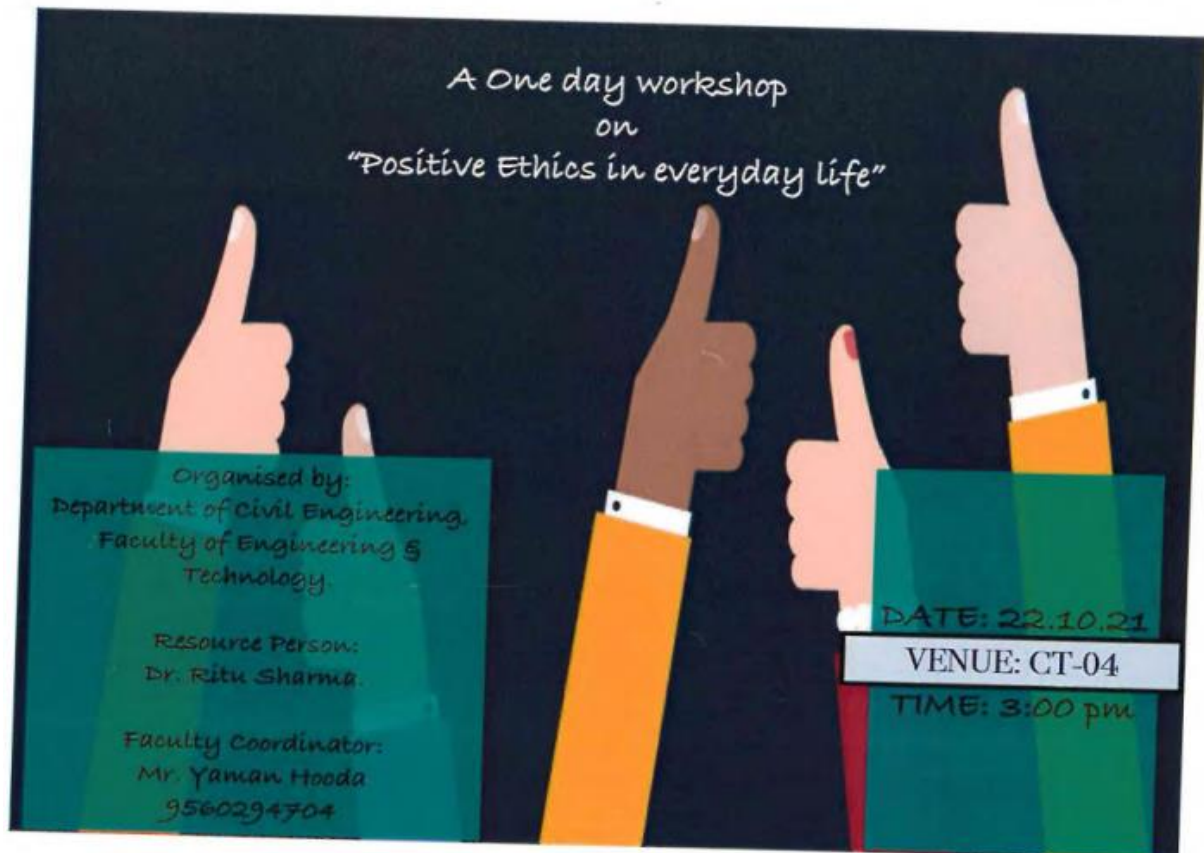

Such a positive focus might help psychologists consider ethical issues in a broader context that could contribute to better decision making and better integration of professional rules with personal principles and values. Positive ethics might also contribute to a greater degree of openness so that psychologists feel freer to seek the assistance of others. With this background, this workshop was organized:

The programme started from 1 p.m. at T-block in TT-02 on 27.09.21 where students were gathered after taking their classes. The student coordinators, Mr. Praduman Singh and Ms. Vanshika Vats assisted faculty coordinators in raising awareness and motivating participants to understand the importance of professional ethics practices in corporates.

Prof. Amit Seth and Dr. Arvind Dalal, the program's speakers, explained the importance of ethics in business practices particularly as an ability and responsibility of a employees to evaluate his/her judgments from the perspective of society's overall well-being. It is the study of moral duties and responsibilities that employees and organizations face while making important decisions in their day-to-day living. They discussed the characteristics of business ethics. Further, they explained that whether a employee works alone or for a firm, they face many ethical difficulties and dilemmas. They elaborated upon the various forms of business ethics like personal responsibility, corporate responsibility, and the importance of values like loyalty, respect, trustworthiness, fairness and community responsibility. When a employees enters into a profession and business world, the speakers discussed the code of professional ethics that follows. The resulting code is crucial in guiding those professionals to conduct themselves, appraise their behavior, and comprehend the profession.



Role of professional Ethics in Competitive World

Ethics explores the nature of rights, of moral responsibilities, and of how to go about addressing an ethical problem. The norm systems governing the behaviour of a professional output includes Individual morality which refers to individual values of a specific person and what they believe to be right; Positive morality and Professional Ethics. In our society ethical concerns have escalated in the past few years and have been raised at government level. Organizations have hot lines for employees to anonymously report unethical behaviour. The question of ethical practice, however, covers broad ground and encompasses everything we do as professionals and the way we behave towards each other in the competitive world of today.
