1. Preamble

Manav Rachna International Institute of Research and Studies-MRIIRS is dedicated to advancing Sustainable Development Goal 16– "Peace, Justice, and Strong Institutions." We believe that education plays a vital role in nurturing the values of peace, justice, and effective governance. Our commitment extends to fostering a culture of ethics, accountability, and inclusivity within our institution, thereby contributing to the broader goal of building strong societies. Through our academic programs, research, and community engagement, MRIIRS strives to empower individuals with the knowledge and skills needed to promote peaceful coexistence and ensure equitable access to justice, reinforcing our commitment to SDG 16.

2. Procedure for formation of Students Council

MRIIRS believes in maintaining transparency and democracy in the system for welfare of its students as a paramount priority. A functioning Student Council exists at MRIIRS with the goal of promoting leadership, cultural values, and camaraderie.

The Council also seeks to mentor students in becoming responsible and contributing citizens of society, as well as to support the University's educational and administrative goals in order to enhance and address various aspects of the entire spectrum of student aspirations.

- **Selection of Student Council through nomination:**

MRIIRS Student Council is formed through a specific selection process. Students are nominated from various departments based on their outstanding performance in sports, cultural activities, and academics.

Nominations are also obtained based on their keen interest and leadership qualities. The office of Dean Students' Welfare shall request all the Head of Departments to nominate the students of their respective departments to the office of Dean Student Welfare with its recommendations for selection of the Students Council every year. After receiving the nominations, the Dean Student Welfare in consultation with the following and based on the recommendations of respective HODs shall further recommend the constitution of student council for the year to the office of Vice-Chancellor for its approval.

1. Director-Sports
2. Coordinator Student Welfare
3. International Student Coordinator
4. Any other member co-opted by DSW

After approval from the Vice Chancellor, the Registrar notifies the final selection of Student Council members. Members of Student Council also serve on academic and administrative committees such as IQAC, Department Academic Committee, Students Grievance Redressal Committee, Antiragging Committee, and so on. The Student Council's goal is to increase students' involvement in various university activities and to provide a sustainable and viable platform for voicing their opinions. The university has a Student Council in place to ensure that students can articulate their aspirations without reservation. This allows students to express their ideas on important issues in a democratic manner. The Council also gives students an excellent opportunity to develop their leadership skills by organizing and carrying out various activities, including extension activities. 5. Nurturing Academic Freedom at MRIIRS

Nurturing academic freedom at MRIIRS is a fundamental principle that ensures a vibrant and intellectually stimulating environment for students, faculty, and researchers. University have also strives for meeting the growing expectations of all stakeholders viz; students, parents, alumni, faculty members and employers in tune with the ever-changing demands of workplace.

Through various educational strategies, MRIIRS seeks to contribute to this goal:

1. Student-Centric Pedagogy: MRIIRS employs a student-centered teaching approach, prioritizing the development of individuals with the knowledge and skills necessary for them to become ethical and competent professionals.

2. **Experiential and Problem-Solving Learning:** The university's teaching methodology incorporates experiential and problem-solving learning techniques, fostering critical thinking, decision-making, and analytical skills that are essential for building peaceful society.

3. **Learner-Centric Curriculum:** MRIIRS has structured its curriculum to ensure excellence in teaching and learning, providing a learner-centric education. This approach promotes inclusivity and equal access to quality education, contributing to the development of a society.

4. **Industry-Oriented Education:** The curriculum focuses on incorporating theory and practical lab courses, equipping students with industry-relevant knowledge and skills. This approach contributes to build strong institutions and fostering innovation.

5. **Internships and Field Experience:** MRIIRS mandates institutional and industrial internships, along with regular industry and field visits. These experiences enhance students' understanding of real-world challenges and promote a sense of responsibility and a commitment to addressing social and global issues.

6. **Diverse Teaching Methods:** The university believes in 'Multiple Intelligence' pedagogy and diverse teaching and learning methods which focus on promoting inclusivity, diversity, and access to education.

7. **Manav Rachna Innovation and Incubation Centre (MRIIC)** supports students in realizing innovative projects, leading to patents and research publications.

8. **Participative Learning:** MRIIRS incorporates various participative learning activities, including debates, presentations, and group discussions. Such activities encourage open dialogue and the exchange of ideas by the students.

9. **Online Collaborative Learning:** By encouraging students to enroll in Massive Open Online Courses (MOOCs) and online learning platforms, MRIIRS facilitates access to education and knowledge sharing, has freedom to pursue their studies in their field of interest. Students are encouraged to enrol for MOOCs for ICT based collaborative learning (Active NPTEL local chapter is well in place). A student can also earn credits through online learning platforms like SWAYAM, NPTEL, Coursera, IIRS-ISRO, Udemey etc.

- **Student Centric Teaching-Learning Methodologies**

All teaching departments at MRIIRS shall work towards developing knowledge and skills through experience and participation instead of explaining knowledge/skill, to produce students who are good critical thinkers and problem solvers. Departments shall incorporate student centric learning methodologies which involves students as active learners and helps them to evolve as critical thinkers and problem solvers instead of being a passive learner. At least 30 percent of teaching shall be through participative, experiential and problem-solving based learning methodologies including peer learning.

- i. Course coordinators shall prepare their comprehensive lesson plan mapped with respective course outcome statements while mentioning the mode of delivery.
- ii. The same shall be uploaded to EMS after planning the sessions as per the approved Academic Calendar.
- iii. The HoD shall check the uploaded session plan particularly for mentioned mode of delivery and approve the session plan on EMS before the commencement of classes.
- iv. Department Academic Committee shall monitor the compliance of session plan incorporating student centric teaching-learning methodologies and submit the report to HoD. DAC members must monitor the exposure of students to case studies, major design experiences in their area of interest to complement their problem-solving skills acquired in earlier course work and provide them a platform for collaborative & life-long learning.
- v. HoD shall appoint the industrial visit coordinator, summer internship coordinator, Student's event coordinator, feedback coordinator etc. before commencement of the classes.
- vi. Departments shall organize at least one industrial visit for students of each semester, industrial visit coordinator will submit the proposal for subsequent approval.
- vii. Internship coordinator must guide students for summer internships at industry and institution.
- viii. Student's event coordinator must coordinate to organize regular expert talks, seminars, conferences, quizzes, club activities, Soft skill and Personality development classes, Experience sharing sessions with Entrepreneurs etc. for students to complement the classroom-based curriculum delivery.
- ix. Department project coordinator must guide students to showcase their project designing and development skills at various National and International Platforms.
- x. Each coordinator shall present his/her annual plan during the month of April/May so that the approved plans will be included in the Department's Strategic Perspective Plan.
- xi. Post event report shall be submitted to HoD by respective coordinators.

- **ICT integration in Teaching and learning:**

The university campus is equipped with all the latest ICT amenities for the benefits of the students and faculty members. Use of ICT tools and e-resources must be ensured to promote blended teaching and learning by all the departments. Classroom-based curriculum delivery must incorporate at least 50 percent of delivery through ICT based tools and e-resources.

- i. ICT tools like projectors, virtual classrooms, supplementary audio-video and e-resources must be incorporated in to teaching and learning.
- ii. Teachers must improvise e-learning resources like National Program on Technology
- iii. Enhance Learning (NPTEL), NITTTR Chandigarh Technology Enabled Learning (NCTEL),
- iv. MOOCs through SWAYAM/Coursera/edx, spoken tutorials, virtual labs etc in teaching learning methodologies while promoting blended learning.
- v. GM IT and team shall ensure that students must get all ICT support in the classrooms and be encouraged to perform as digital learners. All students must be provided with lifetime institutional email IDs along with and other e-resources for not restricting their usages within campus computer labs. All staff and faculty members must be provided with official email IDs and IDs for conducting internet based online remote classroom to the students.
- vi. Faculty members, research scholars and students must be provided with plagiarism
- vii. monitoring facility by the library officials. Each course coordinator will ensure that students must be made available with the learning material for each course via: the syllabus, assignment / tutorial sheets and lecture notes through education management system.
- viii. Regular trainings on the latest system, use of the available IT infrastructure, uploading of course contents, lesson plans and creation of assignments/ tutorials, question banks, marking of assignment/tutorials, attendance record maintenance, attainment of course and program outcomes, conduct of surveys for indirect attainment etc must be conducted by IQAC for faculty members to make them understand all the existing and new modules of education management system.
- ix. Faculty members must work towards the development of e-content of their respective courses.

• **Flexibility in Curriculum (CBCS)**

The curriculum of all the programmes shall follow the credit based semester system that accelerates the teaching learning process and enables vertical and horizontal mobility in learning. A good amount of flexibility shall be given in the form of elective courses to be opt by the students in each programme by following the choice based credit system which provides a 'cafeteria' type approach in which the students can

take courses of their choice, learn at their own pace, undergo additional courses and acquire more than the required credits, and adopt an interdisciplinary approach to learning. As such all the proposed courses to be offered for any programme in the University shall be broadly classified under following categories:

- Fundamental Courses
- Core Courses
- Elective Courses

In principle, all the programmes shall comprise of two baskets: Compulsory Course Basket and Elective Courses Basket. The Compulsory basket shall mainly consists of Fundamental and Core courses of the programme and shall, in principle, comprise of 70% and 80-85% of total credits required for award of degree at UG and PG level respectively. Under Elective courses Basket there can be a pool of courses which may be supportive to the discipline of study or providing an expanded scope or enabling an exposure to some other discipline/ domain or nurturing student's proficiency/skill. As such the Elective courses basket shall comprise of Generic Elective Courses, Discipline/Programme Specific Elective Courses and Inter-disciplinary/Open Elective Courses. While designing the curriculum for any programme, department shall ensure that sufficient choice is made available under Elective Courses to opt for course(s) as per his/her choice and area of interest.

- **Provision of Massive Online Open Courses (MOOCs)**

As per the UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulation, 2016. New Delhi, dt. 19th July, 2016, and consequently provisions incorporated in the (MRIIRS) University Ordinance No. 3 "Conduct and Evaluation of Examinations and Programmes leading to all Bachelor's / Master Degree following semester system", the University allows up to 20% of the total courses being offered in a particular program through the online learning courses provided through SWAYAM and other identified MOOCs platforms. Massive Open Online Courses (MOOCs) can be opted by the student under any programme either as Credit Transfer Course under the basket of Open Elective or as Value-Added Course. Under Credit Transfer Scheme, the student shall be allowed to opt for MOOC courses from approved platforms to the extent of 20% of the minimum credits required for award of the degree for which he/she is registered in the University; however, this limit can be increased on the issuance of the revised guidelines by the Regulatory Bodies.

6. मनोवृत्ति Counselling and Wellness Centre

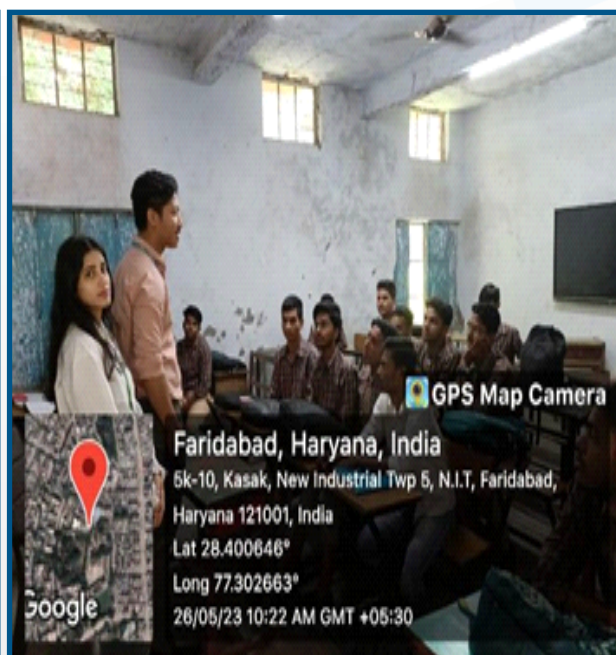

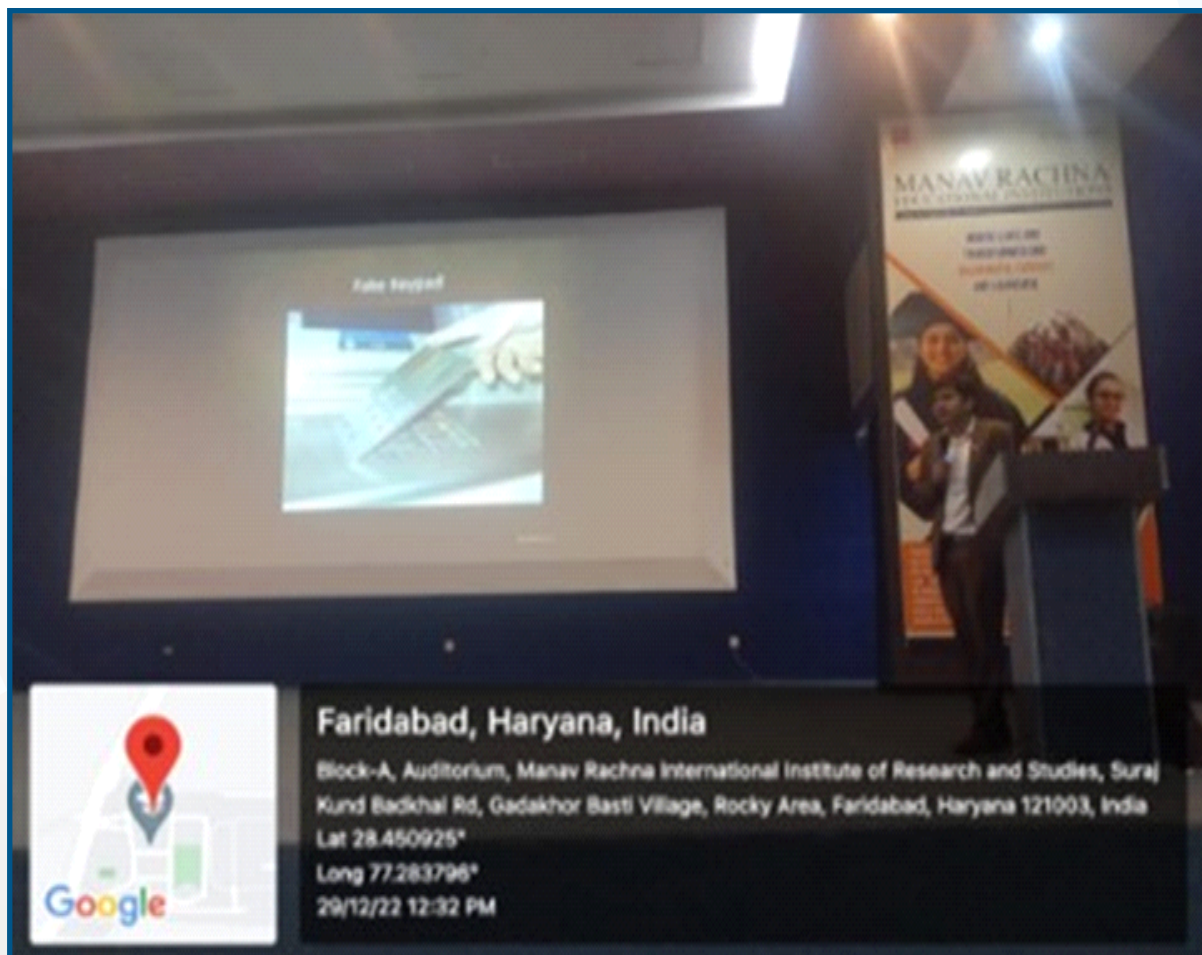

- **Cyber Security Workshop**

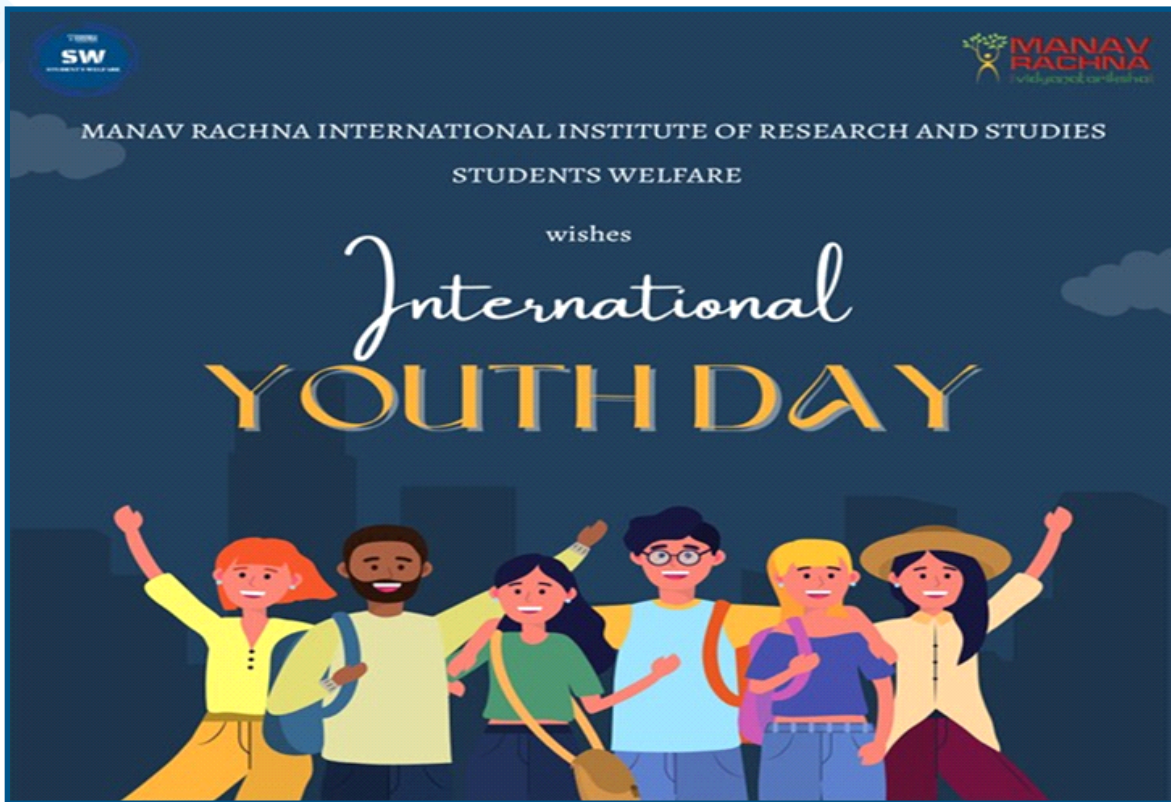

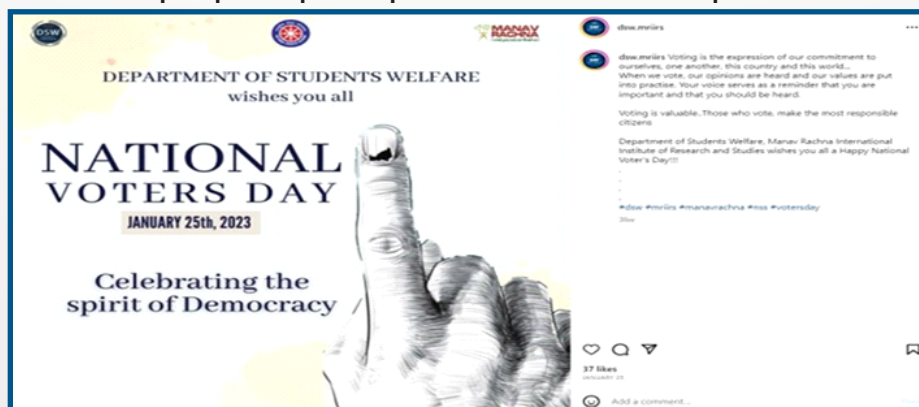
- **International Youth Day**

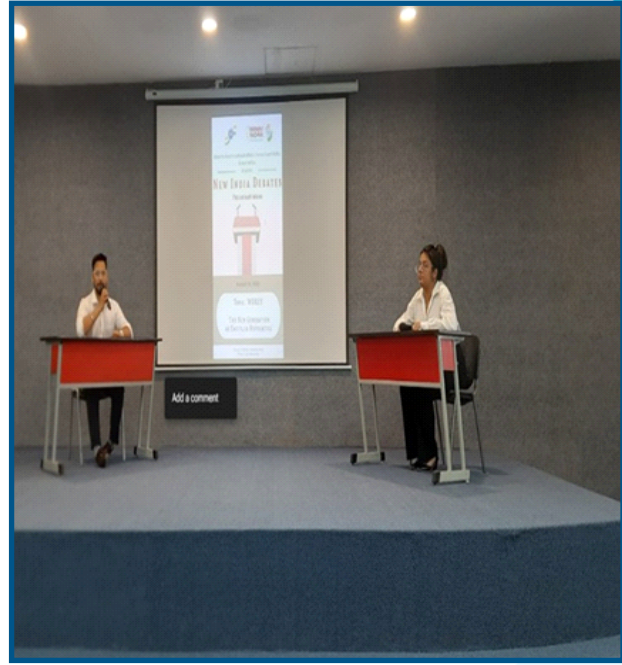

- **Final Round of New India Debates**

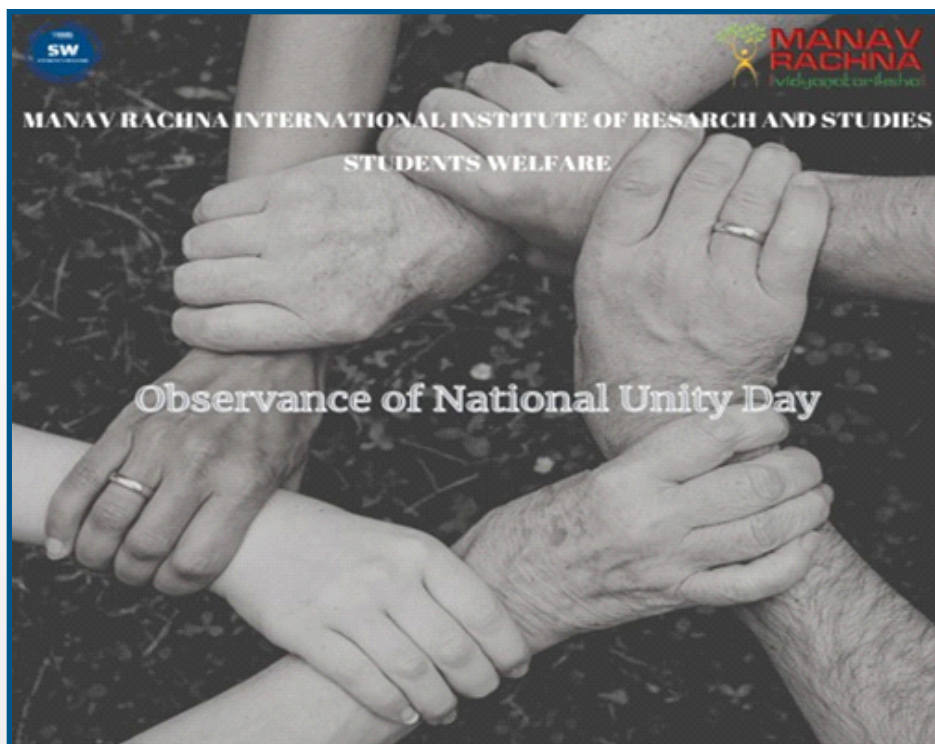

- **Awareness session on Green Environment and Say No to Plastic**

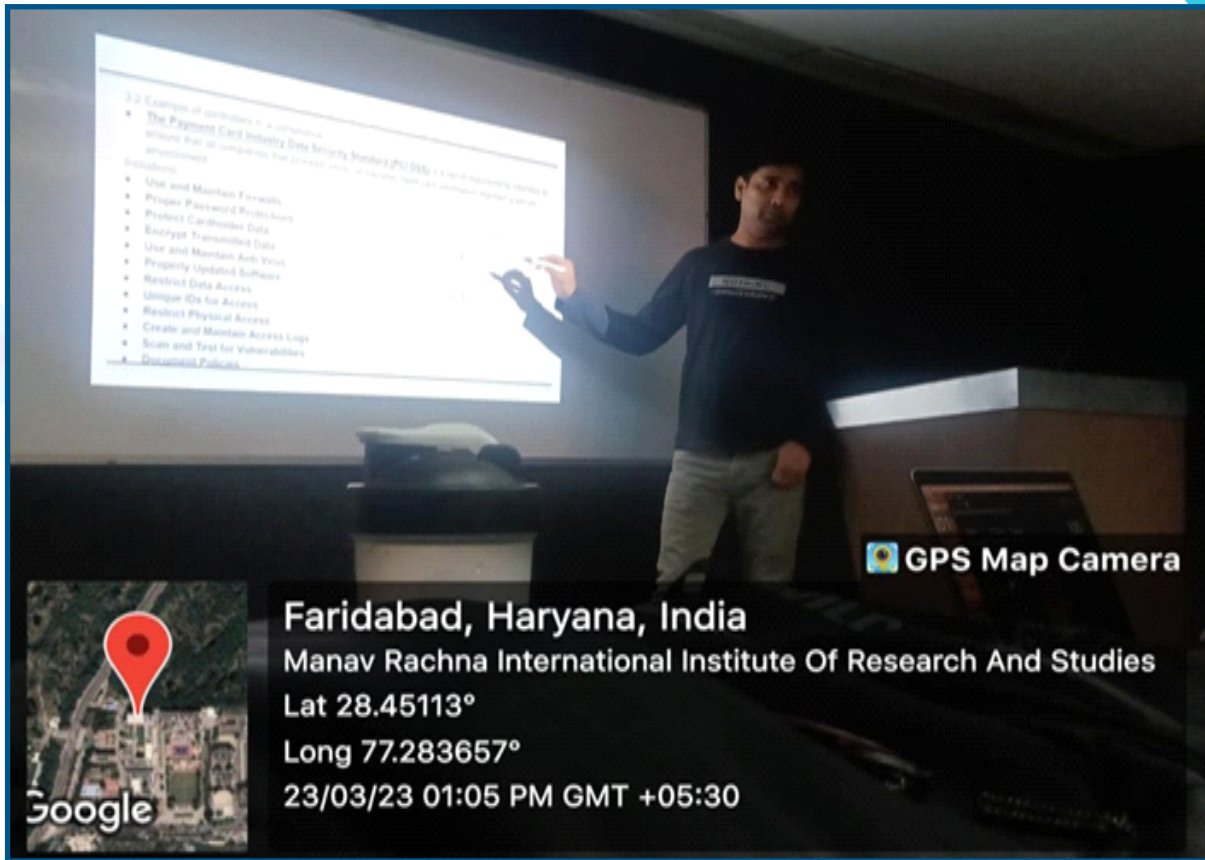
